




TRANSFORMED LIVES

Getting Ready for TAKE OFF

Coaching young people to reach their potential



Getting Ready for Take Off is a project to improve the employment opportunities of youth and young adults up to 25 years affected by parental imprisonment.

Based in our Morphett Vale and Elizabeth hubs, Life Coaches work one-on-one with participants to develop and implement an individualised vocational plan.



GETTING READY FOR TAKE OFF

Getting Ready for Take Off seeks to improve the employability and job-readiness of participants by addressing their particular barriers to education and employment.

Across two hubs, based in Morphett Vale and Elizabeth, the program's Life Coaches work one-on-one with each participant to develop individualised career pathway plans.



For many young people with a loved one in prison, they speak of feeling invisible, overlooked and marginalised by the wider community. With the support of the *Getting Ready for Take Off Project*, our life coaching approach aims to positively impact the emotional, social, physical and mental wellbeing of participants – enabling them to become employable and confident members of society.


WHAT WE OFFER

COACHING PATHWAYS

There are an estimated 40,000 Australian children and young people with a parent in prison. It is estimated there are more than 4,000 here in South Australia alone.

who have been identified as being at high risk of becoming welfare dependent to
transition successfully into the workforce.

The project aims for each PK to develop a **pathway through education** to employment and to break the cycle of inter-generational welfare dependency, helping them become 'Job Ready' towards a fulfilling career.



We offer a wholistic approach to life by providing support with community engagement through sport and the arts, plus healthy mindsets through Life Coaching Retreats.
